Prayer: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus directing the 3rd respondent herein to issue free house site patta to the petitioner in respect of the property comprised in Old Survey No.718/1J Extent, 0.10.0 now New Town Plan Survey No.Ward F, 5th Block, T.S.No.53 extent 0.0186.0 Square meters extent of (2205 square feet), Sevalur Village, Manapparai, Trichy District, by considering the petitioner's representation, dated 27.10.2016.

extent of (2205 square feet), Sevalur Village, Manapparai, Trichy District, during the year 1998. From the said date onwards, the petitioner has been in possession and enjoyment of the property. Subsequently, on 27.09.2016, he has made an application before the respondent Nos.2 and 3 to issue patta in his favour. Since no order has been passed till date, he has filed this writ petition.

4. In view of the fact that the petitioner's application is pending with the third respondent without any disposal from 27.09.2016, the third respondent is directed to consider the said application and pass orders on the same, on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

With the above direction, this Writ Petition is disposed of. No Costs.
