4. The learned counsel appearing for the private respondents would submit that the temple is now under the control of the HR&CE Department, but the department is not impleaded as respondent in this writ petition.

However, considering the submissions of the learned counsel for the petitioner, this writ petition is disposed of with a direction to the second respondent to consider the representation of the petitioner dated 04.11.2016 and pass orders after providing opportunities to the necessary parties, on merits and in accordance with law, on or before 30.11.2016.
