COMMON ORDER

In all these writ petitions, the respective petitioners are seeking for educational loan to their respective children.

2.The learned counsel appearing for the second respondent/Bank in all these matters submitted that the petitioners have not so far given any application for disbursement of the educational loan and as and when they approach the respondent Bank, they would be provided with the application and if they present the application with required documents, the same will be considered on merits and in accordance with the relevant norms.

3.Recording the above said submission of the learned counsel for the respondent Bank, all these writ petitions are disposed of with the following directions:

i)The application for disbursement of the educational loan, on the request, shall be issued to the respective petitioner within a period of 7 days from the date of receipt of a copy of this order.

ii)On receipt of the respective petitioner's application with relevant documents, the same shall be considered and order shall be passed, on merits and in accordance with the rules within a period of four weeks thereafter.

4.Accordingly, all the writ petitions are disposed of. There is no order as to costs.
