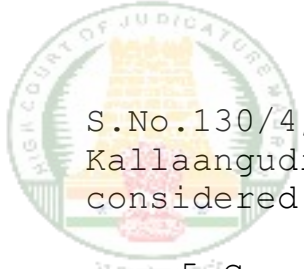
ORDER

4.The grievance of the Petitioner is that the above said application/representation submitted by the Petitioner to conduct a survey and to fix the boundaries of the Petitioner's property in



S.No.130/4, measuring an extent of 0.19.0 hectares, situated at Kallaangudi Group, Karaikudi Taluk, Sivagangai, has not been considered so far.

5.Considering the limited scope of the prayer sought for and without expressing any view on the merits of the claim made by the Petitioner, I only direct the first respondent to consider the application/representation of the Petitioner, dated 16.08.2016 and pass orders on the same, on merits and in accordance with law, also by hearing other rival parties, if any, within a period of eight weeks from the date of receipt of a copy of this order.

6.With the above direction, the Writ Petition is disposed of. No costs.
