This writ petition is filed challenging the order passed by the third respondent in cancelling the assessment of land.

2. Heard both sides.

3. It is seen that as against the order passed by the third respondent which is impugned in this writ petition, appeal lies to the District Revenue Officer, Ramanathapuram. Therefore, the petitioner has to exhaust such alternative remedy. Without doing so, the present writ petition cannot be entertained.

4. Accordingly, this writ petition is dismissed only on the ground that the petitioner has to avail alternative remedy of appeal. The petitioner is at liberty to file such appeal before the second respondent within a period of three weeks from the date of receipt of copy of this order. It is also made clear that this Court is not expressing any view



on the merit of the claim made by the petitioner. Consequently, connected W.M.P. (MD) No.17640 of 2016 is also dismissed.
