This writ petition has been filed, seeking a direction to the respondent herein to grant permission for conducting cultural activities, Adal Padal on 17.02.2016 in connection with the festival in Kaliyampatti Sree Mariamman Kovil at 4/175-A North Street, Kaliyampatti & Post, Duraiyur Taluk, Trichy District based on representation dated 10.02.2016.

Learned counsel for the petitioner would submit that the villagers jointly decided to conduct cultural activities, Adal Padal on 17.02.2016 in connection with the festival in Kaliyampatti Sree Mariamman Kovil at 4/175-A North Street, Kaliyampatti & Post, Duraiyur Taluk, Trichy District. He would further submit that in this connection, a representation was given to the respondent police on 10.02.2016, with a request to grant permission to conduct the programme on the above said date. However, the respondent Police has not yet considered the said



representation and hence, the petitioner is before this Court with this Writ Petition.

3. Heard the learned counsel on either side.
