This writ petition has been filed, seeking a direction to the respondent to grant permission and protection for Adal Padal programme scheduled to be held on 14.03.2016 in Sree Soliyamman Muthusamy Temple at Amman Nagar, Kongu Nagar, Vengamedu Karur District, by considering the petitioner's representation, dated 17.02.2016.

Learned counsel for the petitioner would submit that the villagers jointly decided to perform the cultural event in Sree Soliyamman Muthusamy Temple at Amman Nagar, Kongu Nagar, Vengamedu Karur District, scheduled to be held on 14.03.2016. He would further submit that in this connection, a representation was given to the respondent police on 17.02.2016, with a request to grant permission to conduct the programme on the above said date. However, the respondent Police has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.
