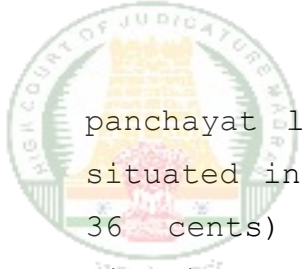

The writ petition has been filed for a Writ of Mandamus directing the first respondent to consider the application dated 05.10.2015 of the petitioner and survey and peg-mark the boundaries of the petitioner
