4. The learned counsel appearing on behalf of the petitioners submitted that it would suffice if the representation of the petitioners are disposed of, on merits and in accordance with law, within a time frame to be fixed by this Court.

In view of the limited scope of the prayer, without expressing any opinion on the merits of the issue involved, the 1st respondent is directed to pass appropriate orders on the representation of the petitioners dated 12.10.2015 and 11.01.2016 respectively on merits and in accordance with law, after giving notice to all the parties or any objectors, if any, within a period of one month from the date of receipt of a copy of this order.
