3. The petitioner seeks for a Mandamus directing the second respondent to dispose of the petitioner's appeal, dated 21.10.2015 within a stipulated time.

4. The case of the petitioner is that he is an Officer in the State Bank of India. On account of certain mislead, of which the petitioner pleaded innocence, he was suspended by an order, dated 03.09.2015, which was received by the petitioner on 10.09.2015. Against which, the petitioner has preferred an appeal before the
