Prayer: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Certiorarified Mandamus calling for the records pertaining to the impugned order ie., rejection order, dated 17.02.2016 passed by the respondent and quash the same and consequently direct him to sanction the educational loan amount of Rs.55,000/- paid by the petitioner for Second Year BE-Mechanical Engineering Course.

ORDER

This Writ Petition has been filed by the petitioner to set aside the rejection order, dated 17.02.2016 passed by the respondent and to direct him to sanction the educational loan amount of Rs.55,000/- for the Second Year BE-Mechanical Engineering Course (2015-2016).

2. According to the petitioner, he is doing his B.E (Mechanical Engineering) Course at PSNJ College of Engineering. He applied for educational loan before the first respondent for the II Year BE-Mechanical Engineering Course(2015-2016). But the respondent vide proceedings, dated 17.02.2016 rejected the petitioner's application stating that they have already closed the educational loan for the current financial year and further, they have already granted educational loan to sufficient number of students. Challenging the said rejection order, the petitioner



has filed this Writ Petition.

3. Today, the learned standing counsel appearing for the respondent/bank fairly submits that the bank will consider the application of the petitioner, within a period of four weeks.
