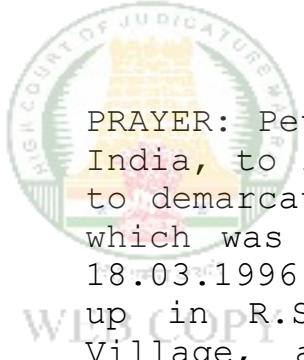

4.Recording the above said submission made by the learned Government Advocate, both these Writ petitions are disposed of with a direction to the 2nd respondent to consider the request of the petitioners and pass appropriate orders on merits and in accordance with law as expeditiously as possible, after receiving the layout approval. Needless to say that the petitioner shall pay necessary fee for such demarcation at the appropriate time. No costs.
