ORDER

This writ petition has been filed for a direction, directing the respondents to grant permission and adequate police protection for conducting kabadi competition tournament conducted by Vinoth Friends Club and Idaya Nilaa at Panaiyur Village, Madurai District, which is scheduled to be held on 19.03.2016 at 10.00 p.m. to 20.03.2016 at 07.00 a.m. by considering the petitioner's representation, dated 14.03.2016.

2. Heard the learned counsel for the petitioner and the learned Additional Government Pleader for the respondents.

3. This Court is aware of the fact that the Election Commission of India has announced time table for elections to the State Assembly and therefore, the Police will be under much strain. Under such circumstances, it will not be advisable to grant permission for such programmes, if there are going to be any law and order problem

4. Without going into the merits of the case, the respondents are directed to consider the representation of the petitioner taking into consideration the antecedents of the petitioner and his capacity to conduct the tournament and all other factors including communal and law and order factors and dispose the same on merits and in accordance with law, expeditiously, preferably on or before 19.03.2016. In the event of



the authorities deciding to give permission, the same should be given only upto 10.00 p.m. and it should include the conditions imposed by this Court in W.P.(MD) No.1474 of 2016 dated 22.01.2016. No costs.
