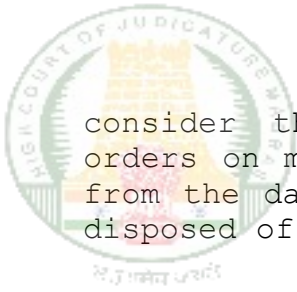
O R D E R

The petitioner seeks for a mandamus, directing the 2nd respondent to disburse the petitioner's agricultural insurance amount of Rs.1,01,108/- in respect of Survey Nos.39/14, 94/3A, 94/2B, 97/2, 97/3, 97/3A, 99/3A, 103/6, 46/2 and 98/4, 193/5B, 213/9 with interest at the rate of 12% per annum for the period of 2013-2014 to the petitioner.

2.It is seen that claiming such benefit, the petitioner has also made a representations on 01.10.2015, 21.11.2015 and 10.12.2015. Therefore, it is for the 2nd respondent to consider such request and pass orders on merits and in accordance with law by considering the eligibility of the petitioner.
