Mr.D.Sivaraman, learned Standing Counsel takes notice for the respondents.

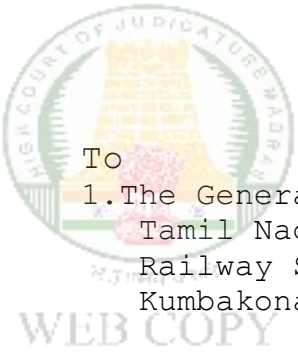
3.According to the petitioner, he was appointed as Clerk in the
