This Writ Petition has been filed seeking issuance of a Mandamus to direct the respondent herein to implement the order passed by the Labour Inspector, Nagercoil in his proceedings in Na.Ka.No.279/2014, dated 31.12.2014 and make the Petitioner permanent in service and give the status of Conferment from 30.11.1991.

2.Mr.S.Kumar, learned Additional Government Pleader takes notice for the respondent.

3.By consent of both sides, the main writ petition is taken up for final disposal at the stage of admission itself.
