ORDER

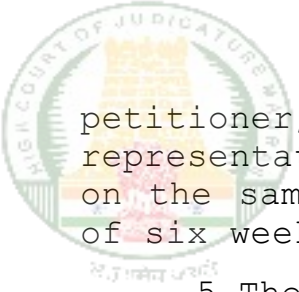
Mr.D.Sivaraman, learned standing counsel takes notice for the respondents. By consent, the writ petition is taken up for final disposal at the stage of admission itself.
