This writ petition has been filed, seeking a direction to the respondent to grant permission and protection for Sri Arulmigu Mariamman Temple at Kuruvampatti Village, Solaganallur Post, Manachanallur Taluk, Trichy District, Pin 621 213 on 22.05.2016 and for the "Aadal Padal dance" programme on the basis of the representation given by the petitioner dated 02.05.2016.

Learned counsel for the petitioner would submit that the villagers jointly decided to conduct "Aadal Padal dance" programme for Sri Arulmigu Mariamman Temple at Kuruvampatti Village, Solaganallur Post, Manachanallur Taluk, Trichy District. He would further submit that in this connection, a representation was given to the respondent police on 02.05.2016, with a request to grant permission to conduct the programme on the above said date.

With the above direction, this Writ Petition is disposed of. No costs.
