O R D E R

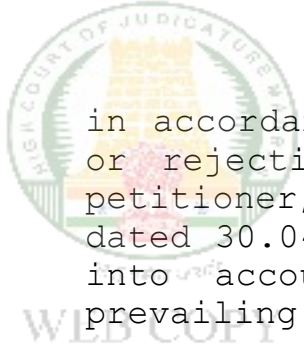
This writ petition has been filed for a direction to the respondent to permit the petitioner to conduct Aadalum Padalum Cultural Program in Sree Pathrakaliamman, Sree Karuppasami Thirukovil, Poduvarpatti Temple festival on 24.05.2016 from 8.00 p.m. to 11.00 p.m.

2. The learned counsel for the petitioner would submit that the villagers jointly decided to conduct "Adal Padal Programme" scheduled to be held on 24.05.2016. He would further submit that in this connection, a representation was given to the respondent police on 11.05.2016, with a request to grant permission to conduct the programme on the above said date. However, the respondent Police has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.
