This writ petition has been filed for a direction to the respondents to grant permission and protection for Adal Padal Program in Thiruvizha scheduled to be held on 25.05.2016 at Arulmigu Sri Ayyanar Thirukovil at Moolakkadai Village, Andipatti Taluk, Theni District, by considering the petitioner's representation dated 05.05.2016.

2. The learned counsel for the petitioner would submit that the villagers jointly decided to conduct "Adal Padal Programme" scheduled to be held on 25.05.2016. He would further submit that in this connection, a representation was given to the respondent police on 05.05.2016, with a request to grant permission to



conduct the programme on the above said date. However, the respondent Police has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.
