O R D E R

This writ petition has been filed, seeking a direction to respondents to grant permission and protection for Adal Padal program in "Vaigasi Pongal Thiruvizha" scheduled to be held on 25.05.2016 at Arulmigu Sri Kanvilichiyamman Thirukovil at R.S.R.Nagar, R.R.Nagar Post, Virudhunagar District by considering the petitioner's representation dated 04.05.2016.

2. Learned counsel for the petitioner would submit that the villagers jointly decided to conduct Adal Padal program in "Vaigasi Pongal Thiruvizha" scheduled to be held on 25.05.2016 at Arulmigu Sri Kanvilichiyamman Thirukovil at R.S.R.Nagar, R.R.Nagar Post, Virudhunagar District. He would further submit that in this representation was given to the respondent police on 04.05.2016, with a request to grant permission to conduct the programme on the above said date. However, the respondent Police



has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.

3. Heard the learned counsel on either side.

4. In view of the limited scope of prayer sought for in this petition, the respondent police are directed to pass orders on merits and in accordance with law either permitting or rejecting the representation dated 04.05.2016, given by the petitioner on or before 25.05.2016, in the light of the previous orders of this Court dated 30.04.2015 passed in W.P.(MD)No.7397 of 2015 and also taking into account the law and order problem and other aspects, prevailing in the area, as expeditiously as possible.

5. With the above direction, this Writ Petition is disposed of. No costs.
