This writ petition has been filed, seeking a direction to the respondents herein to consider the petitioner's representation 02.05.2016 and thereby grant permission to conduct the Adal Padal Programme to be held on 22.05.2016 and 25.05.2016 at about 07.00 p.m., for the Temple festival of Parasakthi Mariamman Pathirakaliamman Kovil.

Learned counsel for the petitioner would submit that the villagers jointly decided to perform Adal Padal Programme for the Temple festival of Parasakthi Mariamman Pathirakaliamman Kovil to be held on 22.05.2016 and 25.05.2016. He would further submit that in pursuance of the representation, a representation was given to the respondent police on 02.05.2016, with a request to grant permission to



conduct the programme on the above said date. However, the respondent Police has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.

In view of the limited scope of prayer sought for in this petition, the respondent police are directed to pass orders in accordance with law either permitting or rejecting the representation dated 02.05.2016, given by the petitioner on or before 22.05.2016 in the light of the previous orders of this Court, dated 30.04.2015 passed in W.P.(MD)No.7397 of 2015 and also taking into account the law and order problem and other aspects, prevailing in the area, as expeditiously as possible.

5. With the above direction, this Writ Petition is disposed of. No costs.
