This writ petition has been filed, seeking a direction to the respondent herein to grant permission to perform the dance programme of Adal Padal on 24.05.2016, night at Arulmigu Shri Poomaroariamman Thirukovil situated in Sankarapandiapuram, Chatrapatti Post, Rajapalayam Taluk, Virudhunagar District and to provide adequate Police Protection based on petitioner's representation dated 14.05.2016.

Learned counsel for the petitioner would submit that the villagers jointly decided to conduct the dance programme of Adal Padal on 24.05.2016, night at Arulmigu Shri Poomaroariamman Thirukovil situated in Sankarapandiapuram, Chatrapatti Post, Rajapalayam Taluk, Virudhunagar District. He would further submit in connection, a representation was given to the respondent police on 14.05.2016, with a request to grant



permission to conduct the programme on the above said date. However, the respondent Police has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.
