ORDER

This writ petition has been filed, seeking a direction to the respondents to grant permission and necessary protection to perform the cultural programme (ie.) Adal Padal on 25.05.2016 at 09.00 pm to 12.00 pm in the eve of Arulmighu Sri Kalamman Thirukovil at Mela Avarampatti Bharathiar Street Rajapalayam Town Virudhunagar District by considering the Petitioner s representation dated 06.05.2016.

2.Learned counsel for the petitioner would submit that the villagers jointly decided to conduct "Adalpadal" Programme in the event of Festival of Arulmighu Sri Kalamman Thirukovil at Mela Avarampatti Bharathiar Street, Rajapalayam Town, Virudhunagar District. He would further submit that in this connection, a representation was given to the respondent police on 06.05.2016, with a request to grant permission to conduct the programme on the above said date. However, the respondent Police has not considered the said representation and hence, the petitioner is before this Court with this Writ Petition.



3. Heard the learned counsel on either side.

4. In view of the limited scope of prayer sought for in this petition, the respondents police are directed to pass orders on merits and in accordance with law either permitting or rejecting the representation dated 06.05.2016, given by the petitioner on or before 23.05.2016, in the light of the previous orders of this Court dated 30.04.2015 passed in W.P.(MD)No.7397 of 2015 and also taking into account the law and order problem and other aspects, prevailing in that area, as expeditiously as possible.

5. With the above direction, this writ petition is disposed of. No costs.
