This writ petition has been filed, seeking a direction to the respondent herein to give permission with protection to conduct the cultural programme in the festival of Arulmigu Sri Kaliasman, Sri Bakavathiamman & Sri Muniappan Thirukoil at Sevanakarayanpatti, Old Kannivadi Village, Dindigul District on 26.05.2016.

2.Learned counsel for the petitioner would submit that the villagers jointly decided to conduct the cultural programme in the festival of Arulmigu Sri Kaliasman, Sri Bakavathiamman & Sri Muniappan Thirukoil at Sevanakarayanpatti, Old Kannivadi Village, Dindigul District on 26.05.2016. He would further submit that in <https://hdservices.ecourts.gov.in/hdservices/>, a representation was given to the respondent police on 12.05.2016, with a request to grant permission to conduct the programme on the above said date. However, the



respondent Police has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.
