Contempt Petition filed under Section 11 of Contempt of Court Act, 1971 praying to punish the respondent for his wilful and deliberate disobedience to the orders of this Honourable Court dated 11.02.2016 in W.P(MD) No.1850 of 2016.

Prayer in WP(MD). 1850/ 2016 : Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the first respondent i.e., the Secretary to Government, Finance Department, Chennai to consider the petitioners representation dt.19.12.2015 and pass appropriate orders regarding his notional promotion on par with his junior Tmt.Thilagavathi (serial No.194) by granting exemption for not passing the Departmental Test as per Govt. Letter No.9140/Service/M/89 dt.20.11.89 and refixation of pension within a specified time frame that may be fixed by this Hon'ble High Court.

ORDER
