Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorari calling for the records relating to the impugned suspension order issued by the 4th respondent in his proceedings No.1/2015 dated 14.06.2016 and the consequential impugned charge memo issued by the 4th respondent in his proceedings No.2/2015 dated 14.06.2016 and quash the same as illegal.

**ORDER**
