Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the Respondents 1 to 3 to approve the appointment of the Petitioner in the Post of Lab Assistant in the 4th Respondent School from the date of initial appointment on 01.07.2016 and to make the payment of salary from the date of initial appointment with all consequential and other attendant benefits, within a time frame to be fixed by this Honble Court.

Prayer in WP(MD). 12731/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the respondent to approve the appointment of the petitioner in the regular sanctioned post of Junior Assistant in the 4th respondent school from the date of appointment on 05/08/2015 and to make the payment of salary with interest and other service benefits.

Prayer in WP(MD). 12732/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the respondents 1 to 4 to approve the appointment of the petitioner in the post of Junior Assistant in the 4th respondent school from the date of initial appointment on 20.06.2016 and to make the payment of salary from the date of initial appointment with all consequential and other attendant benefits, within a time frame to be fixed by this Honble Court.,
