Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a WRIT OF CERTIORARIFIED MANDAMUS, calling for the records pertaining to the proceedings passed by the 4th Respondent in A.Thi.Mu.No.1788/A5/12, dated 12-03-2012 and quash the same and consequently direct the Respondents to approve the Petitioner's appointment as Laboratory Assistant from 05-01-2011.

Prayer in WP(MD). 12051/ 2012 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records pertaining to the proceedings passed by the 4th respondent in A. Thi. Mu.No. 1787/A5/12 dated 12.03.2012 and quash the same and consequently direct the respondents to approve the petitioner's appointment as Office Assistant from 05.01.2011.
