No. 68/32 situated at Keezhpuli Village, Pazhangulam Panchayat, Thiruvadanai Taluk, Ramanathapuram District, on the basis of registered sale deed dated 17.09.1956 with nil encumbrance, as per the representation of the petitioner dated 27.02.2015 within a reasonable time as may be fixed by this Honourable Court.
