Prayer in CRL OP(MD). 8346/ 2015 :

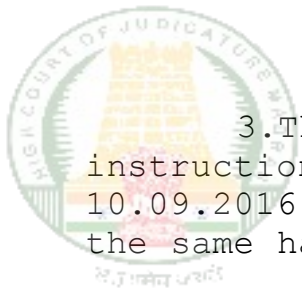
