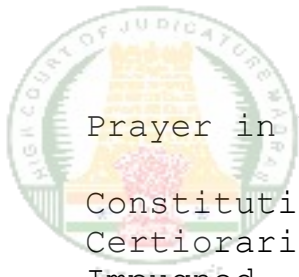

2. In the light of the same, this Contempt Petitions is closed.

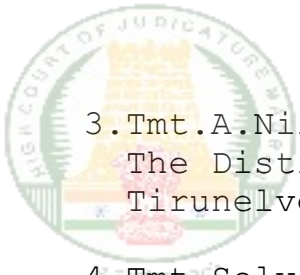
