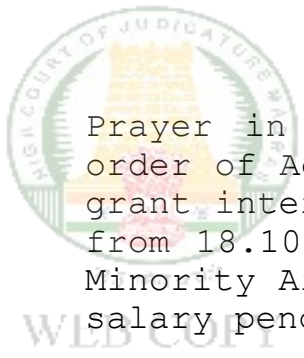

Prayer:- Contempt Petition filed under Section 11 of Contempt of Courts Act, to punish the respondents for willful disobedience of the order passed by this Court made in M.P(MD)No.1 of 2015 in W.P (MD)No.15952 of 2015, dated 17.12.2015.



Prayer in MP(MD). 1/ 2015 in WP(MD)No.15952/2015 : To issue an order of Ad-Interim Direction, directing the respondents 1 to 4 to grant interim approval of the petitioner s appointment with effect from 18.10.2012 as B.T. Assistant (History) in the 5th respondent Minority Aided School without insisting him passing of TET and pay salary pending disposal of the above Writ Petition.

Prayer in WP(MD). 15952/ 2015 : Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of certiorarified Mandamus, calling for the records in connection with the proceedings of the 4th respondent, District Educational Officer, Tirunelveli, bearing Ref. No.NA.KA. 2927/A4/2014 dated 09.07.2014 and quash the same and further direct the respondents 1 to 4 to grant approval of the petitioner s appointment as B.T. Assistant (History) in the 5th respondent minority Aided School in view of the Judgment of the Honourable Supreme Court of India in WP(C)No.1081 of 2013.

ORDER

This Court by the order dated 17.12.2015 issued a direction to the respondents 1 to 4 therein to pay salary to the petitioner from the date of appointment till the disposal of the writ petition and also directed to comply the said direction in six weeks from the date of receipt of the copy of the order.

2.Contending that there is non-compliance of the order and the conduct exhibited by the respondents amounted to willful disobedience to the order passed by this Court, the present contempt petition has been filed.

3.The Learned Additional Government Pleader submitted that already the order passed in M.P(MD)No.1 of 2015 in W.P(MD)No.15952 of 2015, dated 17.12.2015, has been complied with. The said submission is recorded.

4.Nothing survives for adjudication as the compliance has been reported. Hence, the contempt petition is closed.
