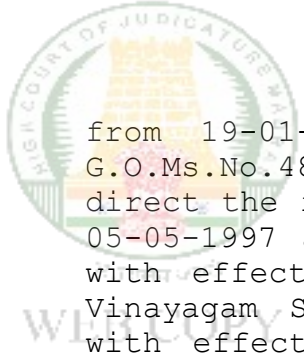
Prayer in CONT.P (MD) 40/2016:

Petition filed under Section 11 of the Contempt of Courts Act, to punish the contemnors/respondents for their misrepresentation in the order dated 06.08.2015, in Contempt Petition No.520 of 2015.

Prayer in CONT P (MD). 520/ 2015 : Petition filed under section 11 of the Contempt of Courts Act 1971, to punish the Respondents/Appellants for committing contempt of Court for disobeying the order of this court dated 15.09.2014 in W.A. (MD) No.963 of 2014.

Prayer in WA (MD). 963/ 2014 : Writ Appeal is filed under Clause 15 of the Letters Patent against the order dated 03.02.2014 in W.P. (MD). No.914/2010.

Prayer in WP (MD) NO.914/2010: Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a WRIT OF CERTIORARI FIED MANDAMUS, calling for the records of the respondents in his proceedings Government letter No.30546/R2/2002-20 Quash the same in so far as regularising the service of the petitioner in Assistant Post



from 19-01-1994 instead of 02-10-1978 as per paragraph 2 (iv) of G.O.Ms.No.487P. & A.R. (Per.M) Dept. dated 18-04-1979 and consequentially direct the respondents to (i) treat the period of reversion 01-11-1996 to 05-05-1997 as on duty (ii) give promotion to the post of Superintendent with effect from 18-11-1993 on par with his junior Thiru.A.Chidambara Vinayagam S.No.796 notionally (iii) Selection Grade in Assistant Post with effect from 16.11.1978 and Special Grade in Assistant Post with effect from 16.11.1988.
