For Respondent :Mr.K.Anbarasan

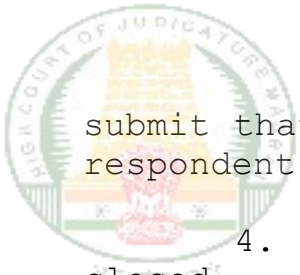
