PRAYER IN WP(MD). No.9611 of 2015

Writ Petition is filed under Article 226 of the Constitution of India for the issuance of a Writ of mandamus, to direct the respondents to pass necessary orders for issuing regular retirement, and consequently to pay all the retirement benefits together with interest at the rate of 12% p.a and awarding Selection Grade with effect from 13.10.1993 and awarding special grade with effect from 13.10.2003 and give due promotion to the post of Depot Manager Gr- I with effect from the date on which his immediate junior was given promotion to the post of Depot Manager Gr-I with all attendant, monitory benefits, regular pension etc. within the time stipulated by this Court.
