Petition filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Mandamus, directing the respondents to settle the petitioner's retirement benefits monthly pension, Employees Provident Fund, Employees Welfare Fund, Earned Leave wages for 16½ days, J.J.Pension and Dearness Allowance payable to him along with monthly pension with reasonable rate of interest within the time that may be stipulated by this Honorable Court.
