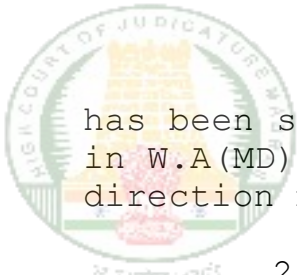
Prayer in WP(MD). 20667/ 2015 :
