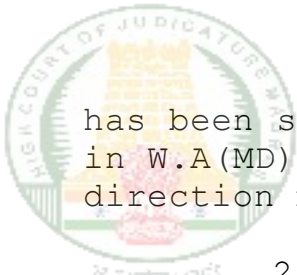
Prayer in WP(MD). 20668/ 2015 :
