Writ Petition has been filed under Article 226 of the Constitution of India, praying for the issuance of a Writ of Certiorarified Mandamus, to call for the records relating to the proceedings of 2nd respondent in letter No. 217/No.9/TNSTC(M)/Tin/2007 dated 06/01/2008 and to quash the same and directing the respondents to fix and pay pension with the arrears under the liberalized pension Rules 1960 to the petitioner.

Prayer in WP(MD). 6501/ 2008 :

Writ Petition has been filed under Article 226 of the Constitution of India, praying for the issuance of a writ of Certiorarified Mandamus, to call for the records relating to the proceedings of 3rd respondent is No.4864/No.9/TNSTC/Ma/Tir/2006 dated 18.6.2008 and quash the same and for direction directing the respondents to provide reliefs and pay the amounts due to the petitioner as per the Madras Liberalized pension Rules 1960 as per G.O.Ms.No.212.

Prayer in WP(MD). 6528/ 2008 :

Writ Petition has been filed under Article 226 of the Constitution of India, praying for the issuance of a writ of Certiorarified Mandamus, to call for the records relating to the proceedings of 3rd Respondent in No.8932/No.9/TNSTC/Mad/Tir/2007 dated 4.12.2007 and quash the same and for direction, directing the respondents to provide reliefs and pay the amounts due to petitioner as per the Madras Liberalized Pension Rules 1960 as per G.O.Ms.No.212,
