Prayer in MP(MD). 3/ 2013 in WP(MD).5424/2013 :

To pass an interim direction to the 1st respondent to release grant in aid to the 3rd respondent school towards the salary of petitioner in respect of sanctioned post of BT Assistant (Science) post at the 3rd respondent school with effect from 20/06/2011 with arrears of salary pending disposal of Writ petition.

Prayer in WP(MD). 5424/ 2013 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorari Mandamus, to call for the records pursuant to the impugned rejection order by the 2nd respondent in



Na.Ka.No.2726/A4/2012 dated 4.1.2013 and quash the same and consequently direct the respondent to approve the petitioners appointment as BT assistant (science) at TDTA middle school, Valliammalpuram, Vallioor Range, Tirnelveli district and give all other service and monetary benefit from 20.6.11.
