3. The learned Government Advocate (Criminal Side) would submit that the petitioners are history sheeters and four cases have been registered against them and they were also detained under Act 14 of 1982. He further submitted that the



petitioner in Crl.O.P.(MD).No.8432 of 2011 died in a motor vehicle accident on 10.08.2016. Further, the representation of the petitioner in Crl.O.P.(MD).No.8442 of 2016, dated 28.05.2011, has been enquired by the Superintendent of Police, and thereafter, it was closed.
