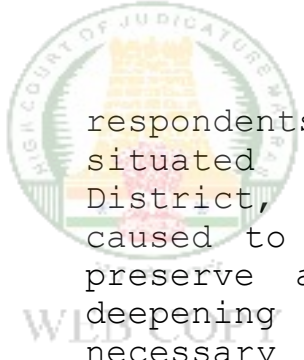

The petitioner has come up with this Public Interest Litigation seeking a direction to the respondents to remove the encroachments made in Oolaiyittan Tank called as Mookuperi Tank, situated in Mookuperi Village, Tiruchendur Taluk, Tuticorin District and to maintain the said tank.

2. It is submitted by the learned Additional Government Pleader that there is no encroachment as of now and the encroachments available had already been removed. The said statement is recorded.

3. So far as the deepening of the tank is concerned, the request of the petitioner will be considered, subject to the financial sanction, it is further submitted.

4. Having regard to all the above, no further direction needs to be issued in this Writ Petition. The Writ Petition is, therefore, dismissed as infructuous. No costs.
