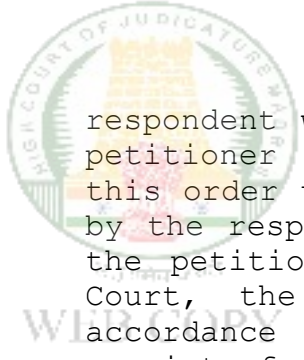

COMMON ORDER

A perusal of the impugned orders in both the Writ Petitions would reveal the fact that they are only a show cause notice calling upon the petitioner to give explanation, instead, the petitioner has come forward with the Writ Petitions. Even in the counter affidavit, it is stated so. Therefore, if the petitioner gives an objection and fourth



respondent will consider the same and pass appropriate orders. Thus, the petitioner is given 15 days time from the date of receipt of a copy of this order to give explanation provided if no final order has been passed by the respondents so far, as the Writ Petition is of the year 2013. If the petitioner replies to the show cause notice as stipulated by this Court, the fourth respondent shall pass orders, on merits and in accordance with law, within a period of three months from the date of receipt of a copy of this order.

2. With the above direction, the Writ Petitions disposed of. No costs. Consequently, the connected miscellaneous petitions are closed.
