Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus to call for the records relating to the order passed by the third respondent in his Na.Ka.No.K5/8563/11 dated 12.01.2012 quash the same and direct the respondents to grant patta to the petitioner in respect of the land in S.No.1394/1 and 1395/1 measuring about 3 acres 20 cents in Moolakaraipatty Village, Nanguneri Taluk, Tirunelveli District by making necessary classification changes.

ORDER

When the matter is taken up for hearing, it is represented by the learned Counsel appearing for the petitioner that the sole petitioner is no more.
