The petitioner submitted a representation dated 11.07.2011 to the first respondent to accept the penal kist from him in respect of the land in Survey No.329, Palayakayal Village, Srivaikuntam Taluk, Thoothukudi District. 2. The first respondent is directed to consider and dispose of the representation dated 11.07.2011 on merits and as per law. Such exercise shall be completed within a period of three months from the date of receipt of a copy of this order.

It is for the first respondent to decide the matter, with notice to all the interested parties.
