O R D E R

The Writ Petition has been filed for a direction to the respondents 1 to 3 to take action against the fourth respondent, based on the petitioner's representation, dated 07.11.2012.

2. According to the petitioner, he is a LCO (Local Cable TV Operator) under the Arasu Cable TV Corporation. The grievance of the petitioner is that he has given a representation to the respondent on 07.11.2012 and So far, the said representation has not been considered by the respondents. Hence, he has filed the present writ petition.



3. Mr. Abdul Saleem, the learned counsel appearing for the respondents/Arasu Cable TV Corporation submitted that they are ready and willing to consider the petitioner's representation within a time limit prescribed by this Court.

In view of the above submission made by the learned counsel appearing for the respondents, the First respondent is directed to consider the petitioner's representation dated 07.11.2012, after giving an opportunity to the petitioner as well as any rival claimant, if any, and pass orders on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.
