The petition coming on for hearing, upon perusing the Petition and the memorandum of grounds filed herein and upon hearing the arguments of Sri Hyma Kumar Yallapragada Advocate for the Petitioner and of the Public Prosecutor, (TG), for the Respondent, the Court made the following.

ORDER:

“The present application is moved by way of lunch motion seeking bail on the ground that the condition of the father of the petitioner is serious.

Learned counsel for the petitioner placed before the Court the medical prescriptions and also certificates issued by the doctor to show that the condition of the father of the petitioner by name D. Raji Reddy is serious.

In view of the above, the petitioner shall be released on bail on his executing personal bond for Rs.10,000/- (Rupees ten thousand only) with two sureties for a like sum each to the satisfaction of XXI Metropolitan Magistrate, Cyberabad at Medchal.

This interim bail shall be in force till 27.07.2016.
