Petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue any writ or direction more particularly one in the nature of Writ of Mandamus declaring the inaction of the respondents not to disturb or disposes the petitioners from the lands in Sy.Nos. 25 and 76 in an extent of Ac.16.32 cents and 14.70 cents situated in Nujellapalli Village, J.Panguluru Mandal, Prakasam District without following due process of law by holding the proposed action of the respondents to auction the lease hold rights as illegal arbitrary and without jurisdiction.

WPMP. NO. 25172 OF 2015:

Petition under Section 151 of C.P.C. Praying that in the circumstances stated in the affidavit filed in W.P., the High Court may be pleased to direct the respondents 3 to 5 not to auction the lease hold rights of the lands in Sy.Nos. 25 and 76 in an extent of Ac.16.32 cents and 14.70 cents situated in Nujellapalli Village, J.Panguluru Mandal, Prakasam District, pending disposal of WP No. 19480 of 2015 on the file of the High Court.
