“For the reasons and in the circumstances stated in the accompanying affidavit, the petitioners herein pray in the interests of justice that this Hon'ble Court may be pleased to issue a Writ of Certiorari or any other appropriate writ, order or direction, calling for the records, pertaining to order dated 05.11.2003 in O.A. No.1243 of 2003 on the file of Hon'ble Central Administrative Tribunal, Hyderabad Bench, Hyderabad and quash the same as illegal, arbitrary, contrary to law and unconstitutional and declare the same as void *ab initio*, null and void and *no nest* in the eyes of law and pass such other and further order or orders as this Hon'ble court may deem fit and proper in the circumstances of the case.
